This service	contract is	subject to the	following:				

- 1. Booking Fee of \$150.00 of the above fee payable with this contract and the balance of \$450.00 plus all unpaid board (\$5.00 per day dry/\$7.00 wet (mare with foal)) and expenses will be payable upon receipt of invoice or when mare is picked up, whichever is first.
- The mare shall be healthy and in sound breeding condition. A veterinarian's statement of
  mare's breeding soundness shall accompany each mare, and failure to furnish this will result
  in the mare not being accepted at Bridle Ridge Gaited Horses for breeding. It is out not our
  responsibility to have your mare examined for breeding soundness.
- 3. A negative culture must be provided within 30 days of breeding to the above stallion. If the mare has been exposed to other stallions or geldings and has not had a negative culture within the last 30 days, the mare will be refused. BRGH reserves the right to have the mare checked if there are concerns in this matter. This will be paid for by the mare owner.
- 4. We do not accept wet mares (mares with foals).
- 5. Mares that are not halter broke, are in ill/poor health, or unmanageable will not be accepted. Rear shoes must be pulled prior to arriving at Bridle Ridge Gaited Horses or mare will not be accepted.
- 6. It is my understanding that Bridle Ridge Gaited Horses hereinafter referred to as BRGH, will not be held responsible for accident, sickness, or death to my mare and/or her foal. BRGH will exercise judgment in the care and supervision of mare/foal.
- BRGH agrees to diligently try to settle my mare. If, however, the mare does not settle, I will hold BRGH harmless.

- 8. BRGH will not guarantee a live foal for any mare that is not ultrasounded within 30 days of last cover date. If the mare is ultrasounded within 30 days of last cover date and confirmed in foal, BRGH guarantees a live foal from this mating. Should the foal not stand and suck, we will give your mare a return privilege the following breeding season. The guarantee will apply only if BRGH is notified within 48 hours of foal's death. A statement from a licensed veterinarian must accompany this notice. The mare owner will be responsible for boarding/mare care fees if this occurs.
- 9. It is further agreed that if the above-named mare should die, or become unfit, then this contract shall become null and void. A statement from a licensed veterinarian must accompany this notice.
- 10. It is further agreed that if the said stallion, SCR's Special Attraction, should die, become unfit for service or sold then this contract shall become null and void. If sold before breeding, the booking/ breeding fee will be refunded.
- 11. If mare/foal requires emergency medical attention while at BRGH, you have authority to call a licensed veterinarian, even if unable to reach mare owner in advance: Authorization to call veterinarian\_\_\_\_\_\_ (mare/foal owner).
- 12. Booking fee is not refundable. **All expenses must be paid before or when mare is picked up.**
- 13. When BRGH signs and returns a copy of this contract to me, it will then be a binding contract on both parties, subject to the above conditions. Negative Coggins is required on all mares, Test No: \_\_\_\_\_\_. Wisconsin State law requires a current Coggins to be within the fiscal year (January to January). If the mare is from out of state, a valid (within 30 days of arrival to BRGH) interstate health certificate needs to accompany the mare.
- 14. BRGH agrees to execute all necessary documents for the registration of the foal resulting from the breeding at any time after the mare has foaled and all outstanding balances are paid in full.

The terms of this agreement are governed by the laws of the State of Wisconsin.
